DECLARATION OF MARY J. BLIGE

I, Mary J. Blige, state that I am the Chief Executive Officer of Mary Jane Productions, Inc., a New York state corporation.

1. Pursuant to Section 503.06(b) of the Trademark Manual of Examining Procedure, I hereby submit this Declaration in support of the typographical error that I wish to correct on the Trademark Assignment that was recorded on December 6, 2016 at Reel/Frame: 5935/0842 in connection with the following United States Trademark Registrations: *MY LIFE*, Reg. No.: 3,865,908; *MY LIFE*, Reg. No.: 4,067,465 and *MY LIFE BLOSSOM*, Reg. No.: 4,113,158 (collectively, the "MY LIFE Trademark Registrations"), as further explained herein.

2. The MY LIFE Trademark Registrations were initially registered to Carol's Daughter Holdings, LLC on October 19, 2010, December 6, 2011 and March 13, 2012, respectively. On June 13, 2012, the MY LIFE Trademark Registrations were assigned from Carol's Daughter Holdings, LLC to my company, Mary Jane Productions, Inc., pursuant to the Trademark Assignment recorded on December 6, 2016 at Reel/Frame: 5935/0842 (the "Originally Recorded Trademark Assignment").

3. It was intended by the Originally Recorded Trademark Assignment that the MY LIFE Trademark Registrations be assigned to my company, Mary Jane Productions, Inc., an active New York corporation that was formed on May 24, 1996. After the Originally Recorded Trademark Assignment was recorded on December 6, 2016, however, it came to my attention that the Originally Recorded Trademark Assignment erroneously listed the state of incorporation for the Assignee, and my company Mary Jane Productions, Inc., as the state of Florida instead of the state of New York.


4. As a result of the recordation of the Originally Recorded Trademark Assignment, the MY LIFE Trademark Registrations are currently listed as being owned by Mary Jane Productions, Inc., a *Florida* corporation which I have no affiliation with whatsoever. The correct owner of the MY LIFE Trademark Registrations is my company, Mary Jane Productions, Inc., a *New York* corporation, and therefore, the Originally Recorded Trademark Assignment must be corrected to reflect the correct state of incorporation for my company.

5. In order to correct the state of incorporation for my company Mary Jane Productions, Inc. from the state of Florida to the state of New York, I crossed out reference to "Florida" in the second WHEREAS clause of the Originally Recorded Trademark Assignment, and handwrote in "New York" in its place. I also initialed and dated this handwritten change directly on the Originally Recorded Trademark Assignment and I am submitting this Declaration in support of this change, which I personally made. In order to effectuate the change to the state of incorporation, both the revised Originally Recorded Trademark Assignment with the aforementioned handwritten change, and this Declaration, will be recorded with the USPTO's Assignment Recordation Branch.

All statements made herein of my own knowledge are true and all statements made on information and belief are believed to be true; and further, the statements are made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code, and that such willful false statements may jeopardize the validity of any application or registration resulting therefrom.
