TRADEMARK ASSIGNMENT

THIS Assignment (the "Assignment") is made and effective as of this 24th day of January, 2017 between **HASBRO, INC.**, a corporation organized and existing under the laws of the State of Rhode Island, having its principal place of business located at 1027 Newport Avenue, Pawtucket, Rhode Island ("Assignor") and **RESTORATION GAMES, LLC**, a corporation organized and existing under the laws of the state of Florida, having its principal place of business located at 12717 West Sunrise Boulevard, #244, Sunrise, Florida 33323 ("Assignee").

WHEREAS, Assignor is the owner of the trademark **STOP THIEF** and of US Trademark Application serial number 87169035 (the "Trademark"); and

WHEREAS, Assignee is desirous of acquiring the entire right, title and interest in and to the Trademark and Assignor has agreed to sell its entire right, title and interest in and to the Trademark to Assignee.

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the parties hereto agree as follows:

In exchange for Assignee's payment to Assignor of Two Thousand United States Dollars (U.S. \$2000.00), the receipt of which is hereby acknowledged, Assignor hereby grants, sells, conveys, assigns, transfers, delivers and relinquishes exclusively to Assignee, free and clear of all liens and other encumbrances all right, title and interest in and to the Trademark, together with the goodwill of the business that is symbolized by the Trademark. In the case of the U.S. "Intent to Use" trademark application where the trademark has not yet been used in commerce, such application is being assigned as part of the entire business or portion thereof to which the Trademark pertains, as required by Section 10 of the Trademark Act, 15 U.S.C. §1060.

Nothing herein shall be construed as assigning Assignee any copyrights associated with the board game previously marketed by Assignor and/or its predecessor-in-interest under the "Stop Thief" name.
