INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This agreement ("*Intellectual Property Assignment Agreement*") is effective as of January 27, 2017 (the "*Effective Date*") between Willow Lake Sub, LLC, a Minnesota limited liability company (the "*Assignee*"), and H.E. B. Assignors are desirous of assigning all title and rights in and to the Intellectual Property to Assignee;

C. Assignee is desirous of having assigned to it all right, title and interest in and to the Intellectual Property by Assignors;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignors hereby sell, assign and transfer to Assignee all right, title and interest in and to the Intellectual Property of each of the Assignors including but not limited to the Marks, including any applications to register the Marks and any registrations therefor, together with the goodwill of the business symbolized by the Marks, all common law rights related to the Marks, all rights of renewal and extension, and the right to recover for damages and profits for past infringements thereof; and the Domain Names.


