**DECLARATION OF TINA BELFANCE
IN SUPPORT OF REQUEST FOR CORRECTIVE NAME CHANGE
TMEP 503.06(c)**

I, Tina Belfance, hereby declare the following:

1. I am General Manager for Capitol Cups, Inc., a Delaware corporation, having a principal place of business at 960 W. Veterans Blvd., Auburn, Alabama, 36832;
2. I have firsthand knowledge of the facts stated herein in support of the request to correct the ownership of the trademark registrations set forth in Exhibit A, attached;
3. On March 19, 2015, a Change of Name was filed with the Trademark Assignment Branch at Reel 005481/Frame 0721 (see Exhibit B);
4. The Change of Name identified the conveying party as CV Holdings, L.L.C., a Delaware limited liability company. The Receiving Party was identified as CSP Technologies North America, LLC, a Delaware limited liability company. Included with the Trademark Assignment Cover Sheet was a name change of CV Holdings, L. L. C. to CSP Technologies North America, LLC;
5. The previously recorded Change of Name document was not proper, because neither CV Holdings, L. L. C. nor CSP Technologies North America, LLC had at any time an ownership interest in any of the trademark registrations set forth in Exhibit A. Furthermore, neither CV Holdings, L. L. C. nor CSP Technologies North America, LLC has any ownership interest in the registrations set forth in Exhibit A at the present time;

The last correct owner for each of the trademark registrations identified in Exhibit A prior to the recording of the Name Change at Reel 005481/Frame 0721 was Capitol Cups, Inc., a Delaware corporation, and Capitol Cups, Inc., a Delaware corporation, continues to be the correct owner of the marks and registrations set forth in Exhibit A; and
7. Because neither CV Holdings, L. L. C. nor CSP Technologies North America, LLC has any ownership interest in the trademarks or the registrations identified in the Change of Name filed with the Trademark Assignment Branch at Reel 005481/Frame 0721, it is requested that the Corrective Name Change submitted herewith be recorded against each of the registrations identified in Exhibit A and on the Trademark Assignment Cover Sheet submitted herewith.

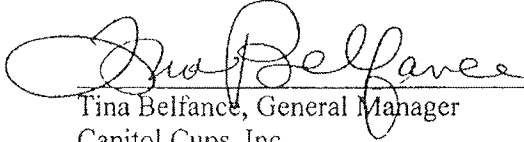

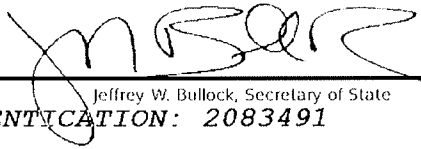

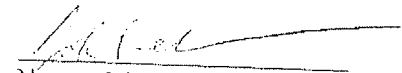
AMENDED AND RESTATED CERTIFICATE OF FORMATION
