RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of February 14, 2017 (this "Release"), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, acting in its capacity as successor administrative agent (in such capacity, the "Administrative Agent") under that certain Security and Pledge Agreement, dated as of December 21, 2012 (as amended, supplemented or modified and in effect from time to time, the "Security Agreement") by and among CLEARCAPTIONS LLC, a Delaware limited liability company (the "Debtor"), the other Obligors party thereto and the Administrative Agent . Capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Security Agreement.

WHEREAS, pursuant to the Security Agreement, the Debtor granted to BANK OF AMERICA, N.A., as the prior administrative agent under the Security Agreement (in such capacity, the "Original Administrative Agent") a continuing security interest in and lien upon all of the Debtor's right, title and interest in, to and under its owned or thereafter acquired trademarks and trademark applications, including, but not limited to, those set forth on the attached Schedule A (the "Trademark Collateral");

WHEREAS, that certain Notice of Grant of Security Interest in Trademarks (the "Notice of Grant"), with respect to the security interest and lien granted by the Debtor under the Security Agreement in the trademark registrations and applications set forth on the attached Schedule A, was recorded with the United States Patent and Trademark Office on January 26, 2015 at Reel 005446 and Frame 0518;

WHEREAS, pursuant to that certain Trademark Security Interest Assignment Agreement, dated as of January 29, 2016 (the "Trademark Security Interest Assignment Agreement"), between the Original Administrative Agent and the Administrative Agent, the Original Administrative Agent transferred, assigned, granted and conveyed to the Administrative Agent all of its right, title and interest in and to the Security Agreement and the Notice of Grant, including, without limitation, its security interest in, and lien on, the Trademark Collateral;

WHEREAS, the Trademark Security Interest Assignment Agreement was recorded with the United States Patent and Trademark Office on February 1, 2016 at Reel 5720 and Frame 0136; and

WHEREAS, the Debtor has requested and the Administrative Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and lien on the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interests created under the Security Agreement in the Trademark Collateral, (b) discharge and release its security interest in and lien on the Trademark Collateral, and (c) reassign any and all rights, title and interest it has in the Trademark Collateral to the Debtor.


THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE DEBTOR'S AND THE ADMINISTRATIVE AGENT'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.
