**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE (“Termination and Release”), dated as of February 16, 2017, from Cerberus Business Finance, LLC, a Delaware limited liability company located at 875 Third Avenue, New York, New York 10022, as Collateral Agent (the “Agent”) for itself and certain other Secured Parties (as described in the Security Agreement, defined below), to Trademen International, LLC (the “Borrower”), a Delaware limited liability company located at 9760 Shepard Rd., Macedonia, OH 44056.

**W I T N E S S E T H:**

WHEREAS, pursuant to the Pledge and Security Agreement, dated as of October 31, 2014, made by the Borrower in favor of the Agent (as amended, restated, supplemented, modified or otherwise changed from time to time, the “Security Agreement”), a continuing security interest (the “Security Interest”) was granted by the Borrower to the Agent in certain collateral, including the Collateral;

WHEREAS, pursuant to that certain Notice of Grant of Security Interest – Trademarks, dated as of October 31, 2014, among the Agent and Borrower (the “Trademark Security Agreement”), Borrower, by reference to the Security Agreement, reaffirmed its intent to grant a Security Interest to the Agent specifically in the Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 4, 2014, at Reel 5393 and Frame 0959; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Collateral pursuant to the Security Agreement, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. Terms not defined herein shall have the meaning given to them in the Trademark Security Agreement or the Security Agreement, as applicable.


2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Collateral, including the Trademarks listed on Schedule A attached hereto, and any right, title or interest of the Agent in such Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
