**RELEASE OF TRADEMARK SECURITY AGREEMENT AND SUPPLEMENT**

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Release"), dated as of January 17, 2017, is made by CoBank, ACB, a federally chartered instrumentality of the United States of America, as agent ("Secured Party"), and is as follows:

WHEREAS, Southern States Cooperative, Incorporated, a Virginia agricultural cooperative corporation ("Debtor"), and Secured Party are parties to: (1) that certain Amended and Restated Trademark Security Agreement dated as of September 18, 2001 (the "First Security Agreement"), which was recorded with the United States Patent and Trademark Office on October 15, 2001, in its records at Reel 002385, Frame 0366; and (2) that certain Supplement to Amended and Restated Trademark Security Agreement dated as of October 19, 2004 (the "Second Security Agreement"), which was recorded with the United States Patent and Trademark Office on October 25, 2004, in its records at Reel 003071, Frame 0747. The First Security Agreement and the Second Security Agreement are collectively called the "Security Agreements."

WHEREAS, the Security Agreements granted to the Secured Party, inter alia, a security interest in all of the Debtor's right, title and interest in, to and under that certain trademark listed on Schedule I of this Release (the "Trademark"), including, without limitation: (a) all of Debtor's right, title and interest in and to, now or in the future, the Trademark; (b) all renewals of each of the items of Trademark; (c) all income, royalties, damages and payments now and in the future due or payable under, or with respect to, any and all Trademark, including damages and payments for future infringements of the Trademark; and (d) all rights to sue for present and future infringements of any and all of the Trademarks; and

WHEREAS, Secured Party desires to release its rights and security interests in the Trademark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby fully and finally releases and terminates its security interest and other rights in, to and under the Trademark.
