WHEREAS, Assignee wishes to acquire the Marks, along with all goodwill appurtenant thereto, and the associated registration, for certain good and valuable consideration.

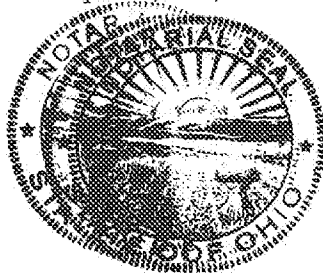
