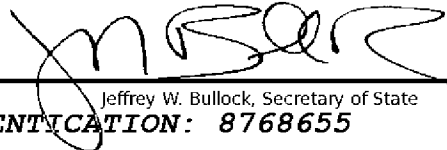

OF CERTIFICATE OF INCORPORATION

The corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware does hereby certify:

**FIRST:** That the Board of Directors of Freedom Speaks, Inc. duly adopted resolutions proposing to amend and restate the Certificate of Incorporation of this corporation, declaring said amendment and restatement to be advisable and in the best interests of this corporation and its stockholders, and authorizing the appropriate officers of this corporation to solicit the consent of the stockholders therefore, which resolution setting forth the proposed amendment and restatement is as follows:

**RESOLVED,** that the Certificate of Incorporation of this corporation be amended by changing the Article numbered "FIRST" so that, as amended, said Article shall be and read as follows:

"FIRST: The name of the corporation is: CitySourced, Inc."

**RESOLVED FURTHER,** that the Certificate of Incorporation of this corporation be amended by changing the Article numbered "Fourth" so that, as amended, said Article shall be and read as follows:

"FOURTH: The Corporation is authorized to issue one class of stock, to be designated "Common Stock," with a par value of \$0.001 per share. The total number of shares of Common Stock that the Corporation shall have authority to issue is 25,000,000."

**SECOND:** That thereafter, the Amendment was duly adopted and approved in accordance with the provisions of Section 228 of the Delaware General Corporation Law by the required vote of the stockholders of the corporation pursuant to a Written Consent of the Stockholders of the corporation;
