TRADEMARK ASSIGNMENT

This ASSIGNMENT between Cave Springs, Inc., a Delaware corporation having its principal place of business at 2751 Centerville Road, Wilmington, Delaware 19808 ("Assignor") and Sears Brands, LLC, an Illinois limited liability company having its principal place of business at 3333 Beverly Road, Hoffman Estates, IL 60179 ("Assignee"), is executed and delivered as of the Execution Date set forth below.

Now, therefore, for good and valuable consideration acknowledged by Assignor to have been received in full from Assignee and pursuant to the terms of the Agreement, Assignor hereby agrees as follows:


Assignor hereby conveys, assigns, sells, and transfers to Assignee its entire right, title and interest in and to the TWO HEARTS mark, including all common law trademark rights, registrations and applications listed on Exhibit A of this Assignment, together with the goodwill, to be held and enjoyed by Assignee or its Affiliates for the full extent of the life of the TWO HEARTS mark, to be used as fully and entirely as such rights would have been held and enjoyed by Assignor had this Assignment not been made. Without limiting the generality of the foregoing, this Assignment shall include all U.S. and foreign common law trademark rights in the TWO HEARTS mark, and any and all rights to sue for claims and remedies against past, present and future infringements of any or all of the foregoing, and rights for priority and protection of interests therein under the laws of any jurisdiction.

Assignor represents, warrants and covenants that Assignor is the owner of the entire right, title and interest in and to the TWO HEARTS mark, and that Assignor has full power to make this Assignment.

This Assignment shall be binding on, and shall inure to the benefit of, the parties hereto and their respective successors and assigns. This Assignment shall be construed, performed and enforced in accordance with, and governed by the laws of the State of Illinois, without giving effect to the principles of conflicts of laws thereof.
