**TERMINATION AND RELEASE OF THIRD LIEN INTELLECTUAL PROPERTY
SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF THIRD LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Termination"), is dated as of February 15, 2017 and made by **WILMINGTON TRUST, N.A.** as third lien collateral agent, located at Rodney Square North, 1100 North Market Street, Wilmington, DE 19890 ("Collateral Agent") to **SIDEWINDER DRILLING LLC**, a Delaware limited liability company, successor by merger to **SIDEWINDER DRILLING INC.**, a Delaware corporation (the "Grantor"), located at 952 Echo Lane, Suite 460, Houston, TX 7024.

WHEREAS, pursuant to that certain Third Lien Intellectual Property Security Agreement, dated as of February 12, 2016, made by Grantor in favor of the Collateral Agent (the "Third Lien IP Security Agreement"), a security interest was granted to the Collateral Agent in certain collateral, including the Collateral (hereinafter, as defined in the Third Lien IP Security Agreement);

WHEREAS, the Third Lien IP Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on February 12, 2016, at Reel 005730 and Frame 0970; and

WHEREAS, the Collateral Agent now desires to terminate and release the Third Lien IP Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Collateral Agent hereby states as follows:

1. Release of Security Interest. The Collateral Agent hereby terminates the Third Lien IP Security Agreement and terminates, releases and discharges its security interest in the Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of the Collateral Agent in the Collateral, including, without limitation, the trademarks listed on Schedule A hereto.

IN WITNESS WHEREOF, the Collateral Agent has caused this Termination to be executed by its duly authorized officer as of the date first written above.
