**TERMINATION OF GRANT OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION OF GRANT OF SECURITY INTEREST IN TRADEMARKS**, dated as of February 17, 2017, is made by Coöperatieve Rabobank Nederland U.A., New York Branch, formerly known as Coöperatieve Centrale Raiffeisen-Boerenleenbank B.A., "Rabobank Nederland", New York Branch, as administrative agent ("Secured Party"), in favor of SF Investments, Inc. ("Grantor").

WHEREAS, pursuant to that certain Grant of Security Interest in Trademarks dated as of July 2, 2009 (the "Agreement"; all capitalized terms shall have the meanings specified in the Agreement) executed by Grantor in favor of JPMorgan Chase Bank, N.A., as administrative agent ("Prior Secured Party"), Grantor previously granted to Prior Secured Party a lien upon and security interest in all Trademarks;

WHEREAS, the Agreement was filed with the United States Trademark and Trademark Office and was recorded on September 15, 2009, at Reel 004061 and Frame 0146 (the "Recording");

WHEREAS, Prior Secured Party assigned all of its interest in the Agreement to Secured Party pursuant to that certain Assignment of Liens dated as of June 6, 2011; and

WHEREAS, Secured Party has agreed to release the lien and security interest granted to it in the Trademarks and to terminate the Agreement and the Recording.

NOW, THEREFORE, for valuable consideration, Secured Party hereby (i) releases any and all liens, security interests, right, title and interest Secured Party may have in, to or under the Trademarks, (ii) re-assigns to Grantor, any right, title or interest Secured Party may have in, to or under the Trademarks, and (iii) terminates the Agreement and the Recording.
