**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS (SECOND LIEN)**

February 21, 2017

WHEREAS, Duke Finance Subsidiary Holdings, LLC (the "Company") entered into (i) a U.S. Collateral Agreement (Second Lien), dated as of October 28, 2015 (as heretofore amended, modified or supplemented, the "Collateral Agreement") among the Company, the other grantors party thereto and Credit Suisse AG, Cayman Islands Branch, as collateral agent (the "Collateral Agent") and (ii) a Notice of Grant of Security Interest in Trademarks, dated as of October 28, 2015 and recorded with the United States Patent and Trademark Office on January 8, 2016 at Reel/Frame 5705/0340 (as heretofore amended, modified or supplemented, the "IP Security Agreement" and, together with the Collateral Agreement, the "Agreements") between the Company and the Collateral Agent, pursuant to which the Company granted a security interest (the "Security Interest") in all of the Company's right, title and interest in and to the Trademarks (as defined in the Collateral Agreement), including without limitation the trademark registrations and trademark applications set forth on the attached Schedule A, all to the extent set forth in the Agreements; and

WHEREAS, the Collateral Agent desires to release the Security Interest.

NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, without warranty or recourse of any kind; hereby releases its Security Interest held in the Trademarks, including without limitation the trademark registration set forth on the attached Schedule A annexed hereto, and hereby, (i) terminates all its rights, powers, privileges and remedies under the Agreements with respect to the Trademarks, (ii) re-conveys, re-transfers and sets over to the Company any right, title or interest that the Collateral Agent may have acquired in the Trademarks, together with all the goodwill associated therewith, and (iii) releases the Company from all covenants, obligations, liabilities and warranties under the Agreements related to the Trademarks.
