**RELEASE OF SECURITY INTEREST  
IN TRADEMARK COLLATERAL**

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL, dated as of February 17, 2017 (this "Release"), is made by **WELLS FARGO BANK, NATIONAL ASSOCIATION**, as agent for the Lenders and the other Secured Parties (the "Agent"), in favor of **NORTH ATLANTIC OPERATING COMPANY, INC.** and **NATIONAL TOBACCO COMPANY, L.P.** ( "Grantors"), as follows. Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Revolving Credit Agreement and Trademark Security Agreement.

**WITNESSETH**

WHEREAS, pursuant to the Trademark Security Agreement, dated as of January 13, 2014 (the "Trademark Security Agreement"), and recorded with the U.S. Patent and Trademark Office on January 15, 2014, at Reel/Frame No. 5193/0577, Grantors granted to the Agent a security interest in and continuing lien on all of Grantors' right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement), including, without limitation, the United States trademarks set forth on Schedule A attached hereto (the "Released Registered Trademarks"); and

WHEREAS, Grantors have requested that the Agent release its security interest in and continuing lien on all right, title and interest of Grantors in, to and under the Trademark Collateral, including the Released Registered Trademarks; and

WHEREAS, the Agent now desires to terminate and release its security interest in and continuing lien on all right, title and interest of Grantors in, to and under the Trademark Collateral, including the Released Registered Trademarks, and reassign any all rights, title and interest in the same to Grantors.

NOW, THEREFORE, the Agent, without recourse, representation or warranty of any kind or nature, and at Grantors' sole cost and expense, hereby terminates, cancels and releases its security interest in and continuing lien on all right, title and interest of Grantors in, to and under the Trademark Collateral, including the Released Registered Trademarks, and any and right, title and interest of the Agent in such Trademark Collateral and such Released Registered Trademarks, including all goodwill associated therewith, is hereby assigned, transferred, and conveyed to Grantors.

The Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.





