## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of February 21, 2017, is executed by WELLS FARGO CAPITAL FINANCE, LLC, a Delaware limited liability company, in its capacity as agent for each member of the Lender Group and the Bank Product Providers (in such capacity, “Agent”), in favor of ALLIANCE ENTERTAINMENT, LLC, a Delaware limited liability company (“Alliance”) and DIRECTTOU, LLC, a Delaware limited liability company (“Directtou” and together with Alliance, each individually as a “Grantor”, and individually and collectively, jointly and severally, as the “Grantors”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement (as defined below).

### RECITALS

A. WHEREAS, each Grantor has, pursuant to that certain Trademark Security Agreement dated September 4, 2013, recorded on September 12, 2013 in the United States Patent and Trademark Office (the “USPTO”) at Reel 5110, Frame 0480, as amended by that certain First Amendment to Trademark Security Agreement, dated as of November 4, 2013, as recorded on November 11, 2013 in the USPTO at Reel 5151, Frame 0476, as further amended by that certain Second Amendment to Trademark Security Agreement, dated as of December 9, 2014, as recorded on January 2, 2015 in the USPTO at Reel 5433, Frame 0479, and as further amended by that certain Third Amendment to Trademark Security Agreement, dated as of July 8, 2016, as recorded on July 13, 2016 in the USPTO at Reel 5833, Frame 0473 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Trademark Security Agreement”) granted to Agent (for the benefit of itself and each member of the Lender Group and the Bank Product Providers) a Security Interest in and to all of such Grantor’s right, title and interest in and to the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the “Released Collateral”); and

B. WHEREAS, Agent, on behalf of itself and each member of the Lender Group and the Bank Product Providers, wishes to terminate and release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself and each member of the Lender Group and the Bank Product Providers, hereby terminates and releases, without representation or warranty, its Security Interest in and to the Released Collateral and terminates the Trademark Security Agreement. Agent acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Grantors. The Agent authorizes the Grantors to record this Release with the USPTO and other applicable registry at the sole expense of the Grantors and agrees to provide the Grantors with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.
