INTELLECTUAL PROPERTY SECOND LIEN SECURITY AGREEMENT RELEASE

This INTELLECTUAL PROPERTY SECOND LIEN SECURITY AGREEMENT RELEASE (the “**Release**”) dated February 23, 2017, is made in favor of SESAC, Inc., a New York corporation, SESAC LLC, a Delaware limited liability company, Rumblefish, Inc., a Delaware corporation, The Harry Fox Agency LLC, a Delaware limited liability company and Christian Copyright Licensing International, Inc., an Oregon corporation (the foregoing, collectively, the “**Grantors**”) by Jefferies Finance LLC, as collateral agent (in such capacity, the “**Collateral Agent**”) for the Secured Parties. All capitalized terms used herein and not otherwise defined shall have the meaning assigned to such terms in the Second Lien Security Agreement (as defined below).

WHEREAS, the Grantors entered into that certain Second Lien Security Agreement, dated as of April 22, 2015 (as amended, amended and restated, waived, supplemented or otherwise modified from time to time, the “**Second Lien Security Agreement**”) among SESAC Holdco II LLC, a Delaware limited liability company, SESAC Holdco I LLC, a Delaware limited liability company, the Grantors, the other grantors party thereto and the Secured Parties;

WHEREAS, under the terms of the Second Lien Security Agreement, the Grantors granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in and to certain intellectual property of the Grantors and the following agreements were executed and delivered by the respective Grantors in favor of the Collateral Agent (each as amended, amended and restated, supplemented or otherwise modified from time to time and, collectively, the “**Second Lien Intellectual Property Security Agreements**”): that certain Second Lien Trademark Security Agreement, dated as of April 22, 2015 by and between SESAC LLC, SESAC, Inc., Rumblefish, Inc. and the Collateral Agent (the “**Second Lien Trademark Security Agreement**”), that certain Second Lien Patent Security Agreement, dated as of April 22, 2015, by and between Rumblefish, Inc. and the Collateral Agent (the “**Second Lien Patent Security Agreement**”), that certain Second Lien Copyright Security Agreement, dated as of April 22, 2015, by and between Rumblefish, Inc. and the Collateral Agent (the “**Second Lien Copyright Security Agreement**”), that certain Supplemental Second Lien Trademark Security Agreement, dated as of November 24, 2015, by and between The Harry Fox Agency LLC and the Collateral Agent (the “**Supplemental Second Lien Trademark Security Agreement I**”), and that certain Supplemental Second Lien Trademark Security Agreement, dated as of May 24, 2016, by and between Christian Copyright Licensing International, Inc. and the Collateral Agent (the “**Supplemental Second Lien Trademark Security Agreement II**”);

WHEREAS, the Supplemental Second Lien Trademark Security Agreement I was recorded with the United States Patent and Trademark Office on April 19, 2016 at Reel 5773 and Frame 0768; and

WHEREAS, in accordance with the provisions of the Second Lien Security Agreement, the indebtedness under has been paid in full, and the Collateral Agent now desires to release its security interest in and to the **Secured Trademarks** (as defined in the Second Lien Trademark Security Agreement and including the Secured Trademarks provided in Schedule A attached hereto), the **Secured Patents** (as defined in the Second Lien Patent Security Agreement

and including the Secured Patents provided in Schedule B attached hereto), the ***Secured Copyrights*** (as defined in the Second Lien Copyright Security Agreement and including the Secured Copyrights provided in Schedule C attached hereto), the ***Supplemental Secured Trademarks I*** (defined as Secured Trademarks in the Supplemental Second Lien Trademark Security Agreement I and including the Supplemental Secured Trademarks I provided in Schedule D attached hereto) and the ***Supplemental Secured Trademarks II*** (defined as Secured Trademarks in the Supplemental Second Lien Trademark Security Agreement II and including the Supplemental Secured Trademarks II provided in Schedule E attached hereto) (the foregoing, collectively, the “***Intellectual Property Collateral***”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Collateral Agent hereby releases to the Grantors its security interest in, and reassigns to the Grantors, without representation or warranty of any kind, any and all right, title and interest in and to the Intellectual Property Collateral, including the Intellectual Property Collateral listed on Schedules A, B, C, D and E, granted to it pursuant to the Second Lien Security Agreement and the Second Lien Intellectual Property Security Agreements, as applicable.

SECTION 2. Recordation. The Collateral Agent authorizes and requests that the applicable officials of the United States Copyright Office and the United States Patent and Trademark Office record this Release.


