RELEASE OF SECURITY INTEREST

Recital

WHEREAS, in connection with that certain Loan and Security Agreement dated as of November 19, 2007, by and among Company, the other Borrowers party thereto and Bank, the Company entered into an Intellectual Property Security Agreement dated as of November 19, 2007, as amended from time to time (the "Security Agreement").
