3. NPB wishes to obtain the Trademarks and the registrations / applications.



For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the parties, Flag hereby irrevocably conveys, transfers, and assigns to NPB all of Flag's rights, title, and interest in and to the Trademark, together with all goodwill associated with the Trademark and: (a) all applications or registrations for the Trademark, including those listed in Paragraph 2; (b) all common law rights in and to the Trademark; (c) all rights of any kind whatsoever of Flag in the Trademark accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions, and otherwise throughout the world; and (d) any and all royalties, fees, income, payments, and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

5. With regard to the rights to the Trademark for retail and online retail store sales, Flag is assigning to NPB the entire portion of the business of Flag to which the Trademark pertains, which business is ongoing and existing.
