INTELLECTUAL PROPERTY RELEASE

THIS INTELLECTUAL PROPERTY RELEASE is made as of February 23, 2017, by U.S. BANK NATIONAL ASSOCIATION, as Collateral Agent (the "Secured Party"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Light Tower Rentals, Inc., a Texas corporation (the "***Company***"), LTR HOLDCO, INC., a Texas corporation ("***Holdings***"; a "***Grantor***", and together with the Company, collectively the "***Grantors***"), certain subsidiaries of Holdings from time to time party thereto and the Secured Party are parties to that certain Intellectual Property Security Agreement dated as of October 7, 2016 (the "Security Agreement") pursuant to which the Grantors granted a security interest to Secured Party in certain Trademarks and Trademark Collateral (as defined below) as security for certain obligations owing by each Grantor to Secured Party, including the trademarks set forth on Schedule 1 hereto (the "Trademarks");

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on October 8, 2016, at Reel 5895, Frame 0839;

WHEREAS, the Grantors have requested that Secured Party release its security interest in the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby releases its security interest in all of the Grantors' right, title and interest in and to the following (collectively the "Trademark Collateral"):

(i) all of its Trademarks and rights in and to Intellectual Property Licenses with respect to Trademarks to which the Grantors are a party including those referred to on Schedule I hereto;

(ii) all reissues, continuations, extensions, modifications and renewals of the foregoing;


(iii) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark Intellectual Property License; and

(iv) all products and proceeds of the foregoing, including, without limitation, any claim by such Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or any Trademark licensed under any Intellectual Property License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Intellectual Property License.
