**THIS DEED** is made on 5 October 2016

**BETWEEN:**

- (1) **BNP PARIBAS S.A.** as security agent and trustee, *mandataire* and parallel debt creditor in accordance with clause 22.5 of the Intercreditor Agreement, for the Secured Parties (as defined in the Intercreditor Agreement as defined below) (the “**Security Agent**”);
- (2) **BNP PARIBAS S.A.** as agent of the Finance Parties (the “**Agent**”);
- (3) **SGD GROUP S.A.S.**, a company incorporated as a *société par actions simplifiée* (limited liability company) under the laws of France, having its registered office at 14 bis Terrasse Bellini, 92800 Puteaux, France and whose registered number is 494 163 876 RCS Nanterre (the “**Parent**”); and
- (4) **THE ENTITIES** listed in Schedule 1 (*Chargors*) (the “**Chargors**”).

**WHEREAS:**

- (A) The Parent, the Chargors, the Agent and the Security Agent enter into this Deed in connection with the Credit Facility Documents and the Senior Secured Notes Documents (as defined in the Intercreditor Agreement (as defined below)) pursuant to the terms of which certain Secured Creditors (as defined in the Intercreditor Agreement (as defined below)) agreed to make available certain credit facilities and/or financial accommodation and/or hold Notes.
- (B) Pursuant to the terms of the Credit Facility Documents and the Senior Secured Notes Documents each Chargor gave certain guarantees and security under each Released Document (as defined below) to which it is a party.
- (C) Under a certain notice of redemption dated 26 September 2016 (the “**Redemption Notice**”), the Parent as issuer has given notice to the holders of the Notes of its intention to redeem the Notes in full on 6 October 2016 (as amended from time to time, the “**Redemption Date**”).
- (D) Under a prepayment and cancellation notice dated 3 October 2016, the Parent has given notice to the RCF Agent that in accordance with the provisions of Clause 11.3 (*Voluntary Cancellation*) and 11.4 (*Voluntary prepayment of Utilisations*) of the Revolving Facility Agreement (as defined below) it intends to prepay and cancel the whole of the Available Facilities (as defined therein) permanently on 6 October 2016.
- (E) The Parent has requested that the Security Agent release and discharge the guarantees, indemnities, security, liabilities and other obligations created by or pursuant to the Released Documents on the terms set out in this Deed.

**IT IS AGREED** as follows:

**1. DEFINITIONS**

- 1.1 In this Deed, in addition to the definitions contained elsewhere in this Deed (including its Schedules):

“**Acknowledgement of Discharge of Indenture**” means the acknowledgement of the satisfaction and discharge in respect of the Indenture from the Senior Secured Notes Trustee to the Parent as issuer, dated on or about the Redemption Date.

“**Effective Time**” means the later of:

- (a) the receipt by the Parent and the Security Agent of the Payoff Confirmation from the Agent; and
- (b) receipt by the Parent as issuer of the Acknowledgement of Discharge of Indenture from the Senior Secured Notes Trustee.

“**Finance Party**” has the meaning given to that term in the Revolving Facility Agreement.

“**Indenture**” means the indenture dated 24 April 2014 in respect of the Notes entered into between, *inter alia*, SGD Group S.A.S. as Issuer, the Senior Secured Notes Trustee and the Security Agent.

“**Intercreditor Agreement**” means the intercreditor agreement dated 24 April 2014 and made between, *inter alia*, the Parent, the Original Debtors (as defined therein), the Agent, the Senior Secured Notes Trustee, the Security Agent and the Original Lenders.

“**Notes**” means the EUR 350,000,000 5.625% senior secured notes due 2019.

“**Payoff Amount**” has the meaning given to that term in the Payoff Letter.

“**Payoff Confirmation**” means the payoff confirmation relating to the Revolving Facility Agreement, to be delivered by the Agent to the Parent (copied to the Security Agent and the other parties listed therein), and by which the Agent confirms due receipt by it of the Payoff Amount, in the form scheduled to the Payoff Letter.

“**Payoff Letter**” means the payoff letter relating to the Revolving Facility Agreement issued by the Agent to the Parent on or about the date of this Deed.

“**Released Documents**” means each document set out in Schedule 2 (*Released Documents*) and all other relevant Transaction Security Documents and/or other documents evidencing, granting or creating Security in respect of the Revolving Facility Agreement and/or the Indenture.

“**Revolving Facility Agreement**” means the super senior revolving facility agreement dated 15 April 2014 for the Parent with BNP Paribas S.A., Credit Suisse International, and J.P. Morgan Limited as Arrangers and BNP Paribas S.A. as Agent and Security Agent, as amended and restated from time to time, under which certain lenders have made available EUR45,000,000 of facilities to the Parent and certain of its subsidiaries.

“**Senior Secured Notes Trustee**” means U.S. Bank Trustees Limited as trustee in respect of the Notes.

- 1.2 Terms defined in the Revolving Facility Agreement or in the Intercreditor Agreement shall have the same meaning when used in this Deed unless a contrary indication appears herein.

## **2. RELEASE AND DISCHARGE**

- 2.1 Immediately upon the occurrence of the Effective Time and without further action by any person, the Security Agent and/or Agent (acting on its own behalf and on behalf of the Secured Parties), as applicable, hereby irrevocably and unconditionally, subject only to Clause 7 (*Continuation*):

- (a) releases and discharges the Chargors and any Guarantors from all present or future, actual or contingent liabilities, obligations, guarantees and Security created, evidenced or conferred by, and all claims, actions, suit, accounts and demands arising under the Released Documents;

- (b) reassigns and retransfers to the Chargors all rights, benefits, interest and title to all assets and property of the relevant Chargor which were assigned or transferred to it by or pursuant to the Released Documents;
  - (c) authorises each Chargor to give notice (at that Chargor's cost and expense) on its behalf of the releases under this Deed to any person on whom notice of any security interest created by the Released Documents was served;
  - (d) agrees that it (or upon the Security Agent's instruction, its legal counsel) shall, on day of the Effective Time, return any share certificates, stock transfer forms and other documents of title held by it pursuant to the Released Documents to the Chargors (or as they may otherwise direct); and
  - (e) releases and discharges the Chargors and any Guarantors under any Released Document from any and all obligations, liabilities, undertakings, covenants and restrictions (whether present or future, actual or contingent and whether guarantee, indemnity, security or otherwise) under the Intercreditor Agreement and any other Debt Document.
- 2.2 Each release and discharge pursuant to Clause 2.1 is given without recourse to or any representation or warranty by the Security Agent or Agent.
- 2.3 Subject only to Clause 7 (*Continuation*), with effect from the Effective Time, the relevant Chargors declare and the Security Agent consents that the power of attorney and every power and authority conferred on the Security Agent under or pursuant to the Transaction Security Documents or the Intercreditor Agreement is hereby revoked and terminated.

### **3. PAYOFF LETTER AND PAYOFF CONFIRMATION**

- 3.1 Following a corresponding request by the Parent identifying the envisaged date of the cancellation and repayment in full of the Facilities under the Revolving Facility Agreement (the "**Refinancing Date**"), the Agent undertakes to issue to the Parent, no later than five (5) Business Days before the Refinancing Date, a Payoff Letter identifying the Payoff Amount for such Refinancing Date.
- 3.2 Upon due receipt by the Agent of the Payoff Amount, the Agent shall issue to the Parent (with a copy to the other parties listed therein) the Payoff Confirmation.

### **4. ACKNOWLEDGEMENT OF DISCHARGE OF INDENTURE**

Promptly after receipt of the Acknowledgement of Discharge of Indenture from the Senior Secured Notes Trustee (and, in any case, on the same date thereof), the Security Agent undertakes to countersign the Acknowledgement of Discharge of Indenture and to send (via e-mail) the countersigned Acknowledgement of Discharge of Indenture to the Parent as issuer, the Senior Secured Notes Trustee, counsel to the Parent, counsel to the Trustee, and counsel to the Security Agent and the Agent.

### **5. RELEASE OF SECURITY PURSUANT TO THE FRENCH LAW SECURITY DOCUMENTS**

- 5.1 As a consequence of the items referred to in Clause 2 (*Release and Discharge*) above, the Security Agent:
- (a) gives full, final and irrevocable release of the pledges over the securities accounts and related cash bank accounts (*compte fruits et produits*) created in accordance with the

provisions of securities account pledge agreements listed in Schedule 2 (*Released Documents*) (the “**Pledges of Securities Account**”);

- (b) gives full, final and irrevocable release of the pledges over shares created in accordance with the provisions of the share pledge agreement listed in Schedule 2 (*Released Documents*) (the “**Pledge of Shares**”) and undertakes to promptly provide the relevant Chargor with an original of the private agreement (*acte sous seing privé*) of release of the pledge of the shares pledge registration substantially in the form set out in Schedule 4 (*Form of Share Pledge Release*), duly completed and executed;
- (c) gives full, final and irrevocable release of the pledges over bank accounts created in accordance with the provisions of the bank account pledge agreements listed in Schedule 2 (*Released Documents*) (the “**Pledges of Bank Accounts**”);
- (d) gives full, final and irrevocable release of the pledges over receivables created in accordance with the provisions of the receivables pledge agreements listed in Schedule 2 (*Released Documents*) (the “**Pledges of Receivables**”);
- (e) gives full, final and irrevocable release of the pledge over business created in accordance with the provisions of the pledge of business agreement listed in Schedule 2 (*Released Documents*) (the “**Pledge of Business**”) and undertakes to promptly provide the relevant Chargor with an original of the private agreement (*acte sous seing privé*) of release of the business pledge registration substantially in the form set out in Schedule 3 (*Form of Business Pledge Release Letter*), duly completed and executed;
- (f) gives full, final and irrevocable release of the pledge over intellectual property rights created in accordance with the provisions of the pledge of intellectual property rights agreement listed in Schedule 2 (*Released Documents*) (the “**Pledge of Intellectual Property Rights**”) and undertakes to provide the relevant Chargor with an original of the private agreement (*acte sous seing privé*) of release of the intellectual property rights pledge registration substantially in the form set out in Schedule 55 (*Form of Intellectual Property release letter*), duly completed and executed; and
- (g) gives full, final and irrevocable release of the assignment of receivables by way of security in accordance with the terms of the Dailly assignment framework agreement listed in Schedule 2 (*Released Documents*) (the “**Dailly Assignment Framework Agreement**”).

5.2 The Security Agent gives all powers to each Chargor (or their legal counsel) in order:

- (a) to notify each Related Pledged Bank Account Holder (as defined in each Pledge of Securities Account) of the release of security granted pursuant to clause 4.1(a) above;
- (b) to notify each Pledged Account Holder and the Pre-Funded Pledged Account Holder (each as defined in each Pledge of Bank Accounts) of the release of security granted pursuant to clause 4.1(c) above;
- (c) to notify each Pledged Debtor (as this term is defined in each Pledge of Receivables) of the release of security granted pursuant to clause 4.1(d) above;
- (d) to register and file the release of security under the Pledge of Shares and the Pledge of Business granted pursuant to clauses 4.1(b) and 4.1(e) above with the relevant registry of the Commercial Court (*greffe du Tribunal de commerce*);



- (e) to register and file the release of security under the Pledge of Intellectual Property Rights granted pursuant to clause 4.1(f) above with the relevant registry of the *Institut National de la Propriété Intellectuelle (INPI)*; and
  - (f) more generally, to take all further useful or necessary actions to give full effect to this and all of the releases of security granted pursuant to this Deed.
- 5.3 The Security Agent acknowledges the right of each Securities Account Holder pursuant to the relevant Pledge of Securities Accounts to register this release in the registers of the relevant Companies (as each term is defined in each Pledge of Securities Account).
- 5.4 The Security Agent:
- (a) waives the benefit of any assignment of receivables by way of security previously made in accordance with the Dailly Assignment Framework Agreement;
  - (b) confirms that no other Bordereaux Dailly is in its possession; and
  - (c) confirms that neither any notice nor any acceptance by the assigned debtors of assignments made pursuant to the Dailly Assignment Framework Agreement have occurred or been requested by the Security Agent.

## **6. RELEASE OF SECURITY PURSUANT TO THE GERMAN LAW SECURITY DOCUMENTS**

- 6.1 Subject to the occurrence of, and with effect from, the Effective Time:
- (a) the Security Agent acting on its own behalf and on behalf of the Secured Parties, as the case may be, in accordance with the provisions of this Deed and/or the Intercreditor Agreement and the Debt Documents, as the case may be, hereby (in each case without recourse, representation or warranty of title):
    - (i) terminates (*aufheben*), surrenders (*aufgeben*) and releases in full (*freigeben*) (in each case without recourse, representation or warranty of title) all pledges (*Pfandrechte*) created under the German Pledge Agreements in accordance with Sections 1273 para. 2, 1255 of the German Civil Code (*Bürgerliches Gesetzbuch*) and waives any liabilities and obligations under the German Law Pledge Agreements and terminates the German Law Pledge Agreements
    - (ii) terminates the German Law Assignment Agreement and re-assigns and/or re-transfers all rights and claims and any other subject matter assigned and/or transferred to the Security Agent under the German Law Assignment Agreement to the respective Assignor (as defined in the German Law Assignment Agreement) and waives any liabilities and obligations under the German Law Assignment Agreement; and
    - (iii) terminates the German Law Security Transfer Agreement and re-transfers and/or re-assigns all Security Assets (as defined in the German Law Security Transfer Agreement) and any other rights, claims or subject matter transferred and/or assigned to the Security Agent under the German Law Security Transfer Agreement to the Transferor (as defined in the German Law Security Transfer Agreement) and waives any liabilities and obligations German Law Security Transfer Agreement.
  - (b) SGD Germany GmbH and SGD Kipfenberg GmbH each accept (i) the re-assignments, (ii) the re-transfers and (iii) the release and/or surrender and/or waiver

with respect to and any termination of the respective German Law Pledge Agreements, the German Law Assignment Agreement and the German Law Security Transfer Agreement.

- 6.2 In the event that the Security Agent and/or any of the Secured Parties have received security interests governed by German law which:
- (a) secured obligations under or in connection with the Debt Documents and all documents related thereto; and
  - (b) are not referred to in sub-Clauses 6.1(a)(i) to 6.1(a)(iii) of this Clause 6 (*Release of Security pursuant to the German Law Security Documents*) (the “**Additional Security Interests**”),

the Security Agent acting on its own behalf and on behalf of the Secured Parties (acting through the Security Agent), as the case may be, upon the occurrence of, and with effect from, the Effective Time, herewith releases any and all such Additional Security Interests to the respective security provider, who herewith accepts such release.

- 6.3 Subject to and with effect from the Effective Time, all authorisations (Vollmachten und Ermächtigungen) (if any), including powers of attorney and bank mandates, granted by SGD Germany GmbH and SGD Kipfenberg GmbH to the Security Agent pursuant to the terms of any of the German Law Pledge Agreements, the German Law Assignment Agreement and the German Law Security Transfer Agreement, shall be revoked and the Security Agent hereby confirms that it will not make use of any of these authorisations and that it will destroy any relevant powers of attorney and/or bank mandates without undue delay.
- 6.4 On the Effective Date each of SGD Germany GmbH and SGD Kipfenberg GmbH will provide the Security Agent with notification forms substantially in the form as set out in Schedule 6 (*Form of Business Account Pledge Release Letter*) hereto containing all information necessary and addressed to the relevant account bank. The Security Agent will without undue delay execute and return these notification forms to SGD Germany GmbH and SGD Kipfenberg GmbH who will without undue delay send them to the relevant account bank in order to inform them about the releases under the Account Pledge Agreement..
- 6.5 In addition, upon the occurrence of, and with effect from, the Effective Time, the Security Agent acting on its own behalf and on behalf of the Secured Parties (acting through the Security Agent):
- (a) authorises each of the pledgors under the German Law Account Pledge Agreement to notify for and on its behalf the relevant account bank of the releases of the pledges created under the German Law Account Pledge Agreement and the termination of the German Law Account Pledge Agreement;
  - (b) authorises each of the German assignors to notify for and on its behalf the relevant debtors of the reassignments and retransfers of the rights and claims assigned under the German Law Assignment Agreement and the termination of the German Law Assignment Agreement;
  - (c) agrees not to use any (blank) notification, registration, security certificate (Sicherungsscheine), (blank) declaration of consent, or any other documents that were provided by SGD Germany GmbH and SGD Kipfenberg GmbH to the Security Agent under or in connection with any of the German Law Pledge Agreements, the German Law Assignment Agreement and the German Law Security Transfer Agreement (together, the "Notifications"). In case that the Security Agent discovers in its

possession any such Notification, it confirms that it will destroy any such Notification without undue delay; and

- (d) agrees that, upon the reasonable request of a relevant released party, it will further do all such things, make any statements and execute all such documents as may be reasonably necessary to give effect to the releases, re-transfers of title, re-assignments, cancellations, terminations and other declarations contemplated in this Deed.

- 6.6 The Security Agent hereby irrevocably terminates and releases (*freigeben*) in full all obligations and liabilities under the Parallel Debt (as defined in the relevant German Law Security Document).

## **7. CONTINUATION**

Notwithstanding any other provision of this Deed, nothing in this Deed is intended to release any person from any confidentiality, indemnification or expense reimbursement obligations contained in the Released Documents or any other Debt Document to which it is a party that are expressly stated to survive the release or termination of the Released Documents or such Debt Document.

## **8. AMENDMENTS AND WAIVER**

Any term of this Deed may be amended or waived only with the written consent of the Chargors and the Security Agent.

## **9. EXPENSES**

In accordance with the Payoff Letter, each Chargor shall pay to the Security Agent the amount of all costs and expenses (including legal fees subject to any applicable arrangements agreed in writing) and any value added tax thereon incurred by it or by any Receiver appointed by it under the Released Documents in connection with the negotiation, preparation, execution and performance of this Deed and the implementation of the arrangements contemplated by this Deed and any related documentation.

## **10. FURTHER ASSURANCE**

The Security Agent will, at the request and cost of any Chargor, do all such things and enter into and execute all such deeds, documents, memoranda, agreements or instruments as may be reasonably necessary to give effect to the provisions of this Deed.

## **11. MISCELLANEOUS**

- 11.1 The Contracts (Rights of Third Parties) Act 1999 shall not apply to this Deed and no rights or benefits expressly or impliedly conferred by this Deed shall be enforceable under that Act against the parties to this Deed by any other person

- 11.2 If any provision of this Deed is or becomes invalid, illegal or unenforceable in any respect under any law, the validity, legality and enforceability of the remaining provisions shall not be affected or impaired in any way.

- 11.3 This Deed may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this Deed.

- 11.4 Failure by one or more parties (“**Non-Signatories**”) to execute this Deed on the date hereof will not invalidate the provisions of this Deed as between the other Parties who do execute

this Deed. Such Non-Signatories may execute this Deed on a subsequent date and will thereupon become bound by its provisions.

- 11.5 It is intended that this Deed takes effect as a deed notwithstanding the fact that a party may only execute this document under hand.

## **12. GOVERNING LAW AND JURISDICTION**

- 12.1 Other than in respect of Clauses 4 (*Release of Security Pursuant to the French Law Security Documents*) and 6 (*Release of Security Pursuant to the German Law Security Documents*), this Deed and any non-contractual claims arising out of or in connection with it shall be governed by and construed in accordance with English law.
- 12.2 Subject to Clause 12.6 below, the Parties agree that the courts of England shall have exclusive jurisdiction to settle any dispute arising out of or in connection with this Deed, whether contractual or non-contractual (including a dispute regarding the existence, validity or termination of this Deed) (a “**Dispute**”). The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no party will argue to the contrary.
- 12.3 The provisions in Clause 2 (*Release and Discharge*) shall also be interpreted in accordance with local law to the extent necessary to make them effective for the purpose intended.
- 12.4 The provisions in Clause 4 (*Release of Security Pursuant to the French Law Security Documents*) shall be governed by, and construed in accordance with, the laws of France.
- 12.5 The provisions in Clause 6 (*Release of Security Pursuant to the German Law Security Documents*) shall be governed by, and construed in accordance with, the laws of Germany.
- 12.6 The Parties agree that, for the benefit of the Secured Parties only, nothing in this Deed shall limit the right of the Secured Parties to bring any legal action against any of the Chargors in any other court of competent jurisdiction.

**IN WITNESS** whereof this Deed of Release has been duly executed as a deed and is delivered on the date stated at the beginning of this Deed.
