# TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is made this 23<sup>rd</sup> day of February, 2017 by and between **RANDALL POINT ENTERPRISES, LLC** ("Assignor"), a Delaware limited liability company, having a principal place of business at 2015 S. Tuttle Avenue, Sarasota, FL 34239, and **INDIBLUE LLC**, a Delaware limited liability company, having a principal place of business at 5900 Wilshire Blvd., Suite 2250, Los Angeles, CA 90036 ("Assignee"):

WHEREAS, Assignor is the owner of the following United States trademarks and trademark applications (hereinafter referred to as the "Marks"):

- **IT'S THE WILD FACTOR**, Registration No. 5064539, for "Energy drinks; Fruit drinks and juices" in International Class 32.
- **INDIBLUE**, Registration No. 5100613, for "Energy drinks; Fruit drinks and juices; Sports drinks, namely, energy drinks" in International Class 32.

WHEREAS, Assignor wishes to transfer all of its rights, title and interest in the Marks to Assignee; and

WHEREAS, Assignee is desirous of obtaining any and all rights, title and interest that Assignor may have in and to the Marks since its date of first use of the Marks, together with the goodwill of the business in connection with which the Marks are used and which is symbolized by the Marks; along with the right to recover damages and profits for past infringement thereof, if applicable.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:


Assignor does hereby assign unto Assignee all right, title and interest in and to the Marks for the United States and throughout the world to the Assignee, together with the goodwill of the business in connection with which the Marks are to be used and which is symbolized by the Marks, along with the right to recover for damages and profits for past infringement thereof, if applicable.

Assignor does further agree to execute and deliver without further consideration all further applications, assignments and documents, and to perform such other acts as Assignee may reasonably request or that are deemed necessary by Assignee, its successors, assigns and nominees, and to fully secure Assignee's ownership interest in the Marks as aforesaid. If Assignor fails, refuses or is otherwise unable to execute such documents, the Assignor hereby appoints the then president of the Assignee as its due and lawful attorney-in-fact with the power of attorney to execute such documents and take such acts under this paragraph as Assignor was required to execute or take, such power being coupled with an interest herein and irrevocable.

This Trademark Assignment may be executed in multiple counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument. Electronic, scanned or other electronically signed versions shall be deemed originals for all purposes herein.


