**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is given as of February 24, 2017, by PROVENTUS CAPITAL PARTNERS II AB (PUBL), in its capacity as Secured Party (as defined in the Security Agreement referred to below) (in such capacity, the “Secured Party”), in favor of AVURE TECHNOLOGIES INCORPORATED, a Delaware corporation (“ATI”), and QUINTUS TECHNOLOGIES, LLC, a Delaware limited liability company (“Quintus”, and together with ATI, each a “Grantor” and collectively, the “Grantors”).

**WITNESSETH**

**WHEREAS**, the Grantors have entered into that certain Facilities Agreement, dated as of March 2, 2014 (as amended, supplemented or otherwise modified from time to time, the “Credit Agreement”), by and among QUINTUS TECHNOLOGIES HOLDING AB, QUINTUS TECHNOLOGIES AB, AVURE, LLC, a Delaware limited liability company, and ATI (together, the “Borrowers”), AVURE HOLDCO, LLC, a Delaware limited liability company, AVURE US INC., a Delaware corporation, Quintus, and the Secured Party as lender.

**WHEREAS**, subject to the terms and conditions of the Credit Agreement, the Grantors have entered into that certain Guaranty, dated as of March 2, 2014 (as amended, supplemented or otherwise modified from time to time (the “Guaranty”).

**WHEREAS**, subject to the terms and conditions of the Credit Agreement and the Guaranty, the Grantors have entered into that certain Security Agreement, dated as of March 2, 2014, in favor of the Secured Party (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”). Capitalized terms used herein without definition shall have the meaning given to them in the Security Agreement.

**WHEREAS**, under the terms of the Security Agreement, ATI granted a security interest in certain of its Trademarks to the Secured Party pursuant to that certain Trademark Security Agreement, dated as of March 2, 2014, in favor of the Secured Party (as amended by that certain Amendment to Trademark Security Agreement, dated as of March 9, 2015, and as further amended, supplemented, or otherwise modified from time to time, the “ATI Trademark Security Agreement”).

**WHEREAS**, under the terms of the Security Agreement, Quintus granted a security interest in certain of its Trademarks to the Secured Party pursuant to that certain Trademark Security Agreement, dated as of March 9, 2015, in favor of the Secured Party (as amended, supplemented, or otherwise modified from time to time, the “Quintus Trademark Security Agreement”, and together with the ATI Trademark Security Agreement, the “Trademark Security Agreements”).

**WHEREAS**, the Grantors and the Secured Party desire that the Secured Party terminate and release its security interest in the Trademarks listed on Schedule 1.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

The Secured Party hereby, on behalf of itself, without representation or warranty, terminates, discharges and releases its continuing security interest and lien in all right, title and interest in the Trademarks pursuant to the Security Agreement and Trademark Security Agreements, and reassigns any and all security interests that it may have therein to the Grantors. The Secured Party hereby authorizes each of Grantors or each of the Grantor's authorized representatives to (i) record this Release with the United States Patent and Trademark Office and (ii) file UCC Financing Statement terminations with the applicable filing office in order to order to memorialize the release of any security interest of the Secured Party in the Trademarks pursuant to the Security Agreement and Trademark Security Agreements.


The Secured Party hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at the Grantors' expense, as reasonably requested by each Grantor and as may be reasonably necessary to effect the release of the security interest in the Trademarks contemplated hereby.

THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK AND SHALL BE BINDING UPON THE SECURED PARTY'S REPRESENTATIVES, SUCCESSORS, ASSIGNS AND TRANSFEREES.




