RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this "Release") is effective as of December 23, 2016, by PNC BANK, NATIONAL ASSOCIATION, in its capacity as Agent (in such capacity, "Secured Party").

WHEREAS, pursuant to that certain Trademark Collateral Assignment and Security Agreement, dated as of July 28, 2011, by SOLAS STAFFING SOLUTIONS, LLC., an Illinois limited liability company ("Solas"), in favor of Secured Party (the "Solas Security Agreement"), Solas granted to Secured Party a continuing security interest in and continuing lien upon all of the trademarks and related assets of Solas, including, without limitation, the trademarks listed on Exhibit A hereto (the "Solas Trademarks");

WHEREAS, the Solas Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on August 15, 2011 at Reel/Frame 004605/0079;

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of October 23, 2013, by APFS STAFFING, INC., a Delaware corporation ("APS Staffing"), and certain of its affiliates and subsidiaries (together with Solas and APFS Staffing, the "Grantors"), in favor of Secured Party (the "APFS Security Agreement"), the Grantors granted to Secured Party a continuing security interest in and continuing lien upon all of the trademarks and related assets of the Grantors, including, without limitation, the trademarks listed on Exhibit B hereto (the "APFS Trademarks"); and


WHEREAS, the APFS Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on November 8, 2013 at Reel/Frame 5150/0024;

NOW, THEREFORE, intending to be legally bound hereby and in connection with each of the Solas Security Agreement and the APFS Security Agreement, Secured Party hereby (i) releases the continuing security interest and continuing lien upon, and terminates its security interest in, and all other rights, title and interest in and to, the Solas Trademarks and the APFS Trademarks, without any recourse, representation or warranty, (ii) terminates the Solas Security Agreement and the APFS Security Agreement, and (iii) re-assigns to the Grantors, any right, title or interest the Secured Party may have in, to or under the Solas Trademarks and the APFS Trademarks, together with the goodwill of the business symbolized thereby, and hereby authorizes the Grantors or the Grantors' authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination. Secured Party further agrees to execute any other documents and take any further action which is reasonably necessary in any state, country, or jurisdiction that the Grantor may reasonably require to effect the intent and purpose of this Release.
