RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT (this “Release”), dated as of January 19, 2017, is made by U.S. Bank National Association, as Collateral Agent (“Secured Party”), and is as follows:

WHEREAS, Southern States Cooperative, Incorporated, a Virginia agricultural cooperative corporation (“Debtor”), and Secured Party are parties to that certain Intellectual Property Security Agreement dated as of August 14, 2013 (the “Security Agreement”), which was recorded with the United States Patent and Trademark Office on August 14, 2013, in its records at Reel 005089, Frame 0331;

WHEREAS, the Security Agreement granted to the Secured Party a security interest in all of the Debtor’s right, title and interest in, to and under certain trademark listed on Schedule I of this Release (the “Trademark”), including, without limitation: (a) all of Debtor’s right, title and interest in and to, now or in the future, the Trademark; (b) all renewals of each of the items of Trademark; (c) all income, royalties, damages and payments now and in the future due or payable under, or with respect to, any and all Trademark, including damages and payments for past or future infringements of any and all of the Trademark; and (d) all rights to sue for past, present and future infringement of any and all of the Trademark; and


WHEREAS, Secured Party desires to release its rights and security interests in the Trademark.
