RELEASE OF SECURITY INTEREST IN TRADEMARKS OF QUATRO COMPOSITES, L.L.C.

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS OF QUATRO COMPOSITES, L.L.C., dated February 28, 2017 (this "Release of Security Interest"), is executed by The PrivateBank and Trust Company, a national banking association, as Administrative Agent, having a business location at 4201 Westown Parkway, Suite 318, West Des Moines, IA 50266 ("PVTB"), in favor of Quatro Composites, L.L.C., an Iowa limited liability company having its principal business location at 403 14th Street SE, Orange City, IA 51041 ("Company").

WHEREAS, PVTB and Company, pursuant to that certain Credit Agreement dated May 11, 2016 (the "Credit Agreement"), entered into that certain Trademark Security Agreement, dated May 11, 2016 (the "Trademark Security Agreement"), whereby Company granted PVTB the Security Interest (as defined in the Trademark Security Agreement) with power of sale to the extent permitted by law, in the Trademarks (as defined in the Trademark Security Agreement) to secure payment of all indebtedness, liabilities and other obligations of Company to PVTB;

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office on May 11, 2016, at Reel 5790; Frame 0632.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, PVTB agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security interest. PVTB hereby releases and terminates the Security Interest, along with any other security interest, right or title it may have with respect to the Trademarks, including with respect to Company's Trademark Registration Nos. 4,360,478 for the mark QUATRO COMPOSITES and 3,832,342 for the mark OPTIPART.
