RELEASE OF SECURITY INTEREST IN TRADEMARKS

February 27, 2017

WHEREAS, BLUE RIVER PETCARE GROUP, LLC, an Illinois limited liability company (the “Company”), and certain affiliates of Company from time to time party thereto have entered into that certain Amended and Restated Credit and Security Agreement (as amended, amended and restated, restated, supplemented modified or otherwise in effect from time to time the “Credit Agreement”), dated as of February 5, 2016, with THE HUNTINGTON NATIONAL BANK (as successor by merger to FirstMerit Bank, N.A.), in its capacity as agent (“Administrative Agent”) for itself and certain financial institutions from time to time party thereto (the “Lenders”), and the Lenders. Capitalized terms used herein but otherwise not defined herein shall have the meanings ascribed to them in the Credit Agreement;

WHEREAS, pursuant to the Credit Agreement, the Company executed and delivered to the Administrative Agent that certain Trademark and License Security Agreement, dated as of February 5, 2016 (as amended, amended and restated, restated, supplemented modified or otherwise in effect from time to time, the “Grant”), which Grant was recorded with the United States Patent and Trademark Office on February 8, 2016 at Reel 5726, Frame 0877; and

WHEREAS, pursuant to the Grant and the Credit Agreement, the Company granted to the Administrative Agent a security interest in the Company’s trademarks and licenses, including, without limitation, the trademark applications identified on Schedule A attached hereto.


