## **RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE dated as of October 29, 2015 (this "Release") is made by Citizens Bank, N.A. f/k/a RBS Citizens, National Association, as agent (in such capacity, the "Agent") under that certain Trademark Security Agreement, dated as of August 31, 2011 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") from Emerson Ecologics, LLC (the "Grantor") to the Agent.
