FIFTH AMENDED AND RESTATED  
CERTIFICATE OF INCORPORATION OF

(a Delaware corporation)

The undersigned, S. Bradford Antle, President of Command Information, Inc., a corporation duly organized and existing under the laws of the State of Delaware (the "Corporation"), does hereby certify that:

1. The name of the Corporation is Command Information, Inc. The Corporation was originally incorporated under the name of Command Information, Inc. The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on August 8, 2005, was amended and restated on January 26, 2006, was amended and restated on August 30, 2006, a Certificate of Correction was filed on August 30, 2006, was amended and restated on April 2, 2008, was amended and restated on September 29, 2009, and a Certificate of Merger with the Fifth Amended and Restated Certificate was filed February 28, 2011.

2. The FIRST paragraph of the Fifth Amended and Restated Certificate of Incorporation of the Corporation, shall be deleted in its entirety and the following FIRST paragraph shall be substituted in lieu thereof:

**"FIRST:** The name of the corporation (hereinafter referred to as the "Corporation") is Salient Federal – Command, Inc."

3. Pursuant to Sections 141 and 242 of the General Corporation Law of the State of Delaware, the board of directors determined that the proposed Certificate of Amendment is advisable and in the best interests of the Corporation and approved and adopted the Certificate of Amendment and directed that the amendment be submitted for consideration and action thereon by the sole stockholder of the Corporation.

4. Pursuant to Sections 228 and 242 of the General Corporation Law of the State of Delaware, the sole stockholder of the Corporation approved and adopted the Certificate of Amendment.
