RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (the "Release") is entered into by Fifth Third Bank ("Fifth Third").

WHEREAS, Performance Assessment Network, Inc., a Delaware corporation (the "Grantor"), executed a certain Security Agreement dated February 1, 2013 (the "Agreement") in favor of Fifth Third, which reflected the security interest granted by the Grantor to Fifth Third in and to the patents identified on Schedule A hereto, and the trademarks identified on Schedule B hereto and the related goodwill (collectively referred to herein as the "Collateral").
