SECURITY INTEREST**

TERMINATION AND RELEASE OF SECURITY INTEREST dated as of January 31, 2017, by BARINGS FINANCE LLC (the "Secured Party").

WHEREAS, ARXAN TECHNOLOGIES, INC. (the "Grantor") and the Secured Party entered into (i) a Patent Security Agreement dated July 30, 2014 (the "Patent Security Agreement"), which Patent Security Agreement was recorded with the United States Patent and Trademark Office on July 31, 2014, at Reel 033451, Frame 0939, as supplemented by that certain Patent Security Supplement dated December 9, 2016 (the "Patent Security Supplement"), and (ii) a Trademark Security Agreement dated July 30, 2014 (the "Trademark Security Agreement"), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 31, 2014, at Reel 5333, Frame 0710, as supplemented by that certain Trademark Security Supplement dated December 9, 2016 (the "Trademark Security Supplement"), for the purpose of securing certain indebtedness and obligations of the Grantor to the Secured Party for the benefit of the lenders party to that certain Credit Agreement dated as of July 30, 2014 (the "Credit Agreement");


WHEREAS, pursuant to the Credit Agreement, the Patent Security Agreement, the Patent Security Supplement, the Trademark Security Agreement and the Trademark Security Supplement, the Grantor pledged and assigned to the Secured Party, and granted to the Secured Party a security interest with power of sale in, certain patents, including, without limitation, the patents listed on Exhibit A hereto, and certain trademarks, including, without limitation, the marks listed on Exhibit B hereto (collectively, the "Intellectual Property"); and

WHEREAS, the Grantor intends to repay certain indebtedness and obligations and terminate the Credit Agreement.

NOW, THEREFORE, in consideration of the foregoing premises, the Secured Party hereby terminates and releases its security interest in the Intellectual Property, and hereby assigns and transfers to the Grantor, without any representation, warranty or recourse whatsoever, all of the Secured Party's right, title and interest in and to the Intellectual Property, effective as of the date set forth above.
