NUNC PRO TUNC TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in accordance with the actual transfer heretofore effected, said Assignor does hereby *nunc pro tunc* sell, assign, set over, and transfer to said Assignee, the entire right, title, and interest in and to the Mark, and the United States registration, together with the goodwill of the business pertaining thereto, the same and the rights of Assignor to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, at common law and /or to the end of the term or terms for which registration of the Mark may be granted, or renewed, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made, with the right to sue for and collect the same for its own use and benefit all claims for past, present and future infringement or misappropriation.

AND, Assignor agrees, at the request of Assignee, to execute any further papers necessary to effect transfer of the Mark as may be required for recordation in a form substantially as set forth herein of this Assignment; and to secure for Assignee in its full and complete enjoyment of its right to the Mark at Assignee's expense.
