**TERMINATION AND RELEASE
OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is executed effective as of February 28, 2017, by First Merchants Bank, an Indiana state-chartered banking institution f/k/a First Merchants Bank, National Association, with a mailing address of 10333 North Meridian Street, Suite 350, Indianapolis, Indiana 46290 (the "Bank"), in favor of Sensory Technologies, LLC, an Indiana limited liability company with a mailing address of 6951 Corporate Circle, Indianapolis, Indiana 46278 (the "Grantor"). Unless otherwise indicated, capitalized terms used herein and not otherwise defined herein shall have the respective meanings provided therefor in the Credit Agreement as referred to below.

WHEREAS, reference is made to that certain Credit Agreement dated as of September 30, 2014 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement"), between the Grantor and the Bank;

WHEREAS, the Grantor executed a certain Trademark Security Agreement dated as of September 30, 2014 for the benefit of the Bank (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement") pursuant to which the Grantor granted to the Bank a continuing security interest in all of Grantor's right, title and interest in, to and under the Trademark Collateral (as defined therein) (the "Security Interest"), including the Trademark listed on Exhibit A hereto, in order to induce the Bank to make Loans;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("USPTO") on October 1, 2014 at Reel 5372 and Frame 0001; and


WHEREAS, the Bank has agreed to terminate and release its Security Interest solely with respect to the Trademark listed on Exhibit A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, the Bank hereby releases, terminates and discharges the Security Interest granted under the Trademark Security Agreement solely with respect to the Trademark listed on Exhibit A hereto, and any right, title or interest of the Bank in such Security Interest in such Trademark listed on Exhibit A shall hereby terminate, cease and become void. This Release does not release, relinquish, discharge or terminate the Banks' security interest in any Intellectual Property or any other asset of the Grantor other than the Trademark set forth in Exhibit A hereto. The Bank hereby consents to the recording of this Release with the USPTO and agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the release of the Security Interest solely with respect to the Trademark listed on Exhibit A as contemplated hereby.
