This Agreement shall be binding upon and inure to the benefit of the parties, their successors, assigns, and personal representatives.

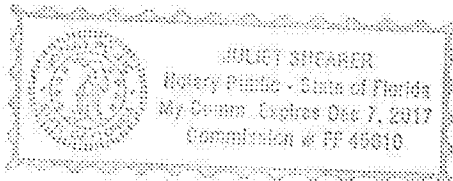
