RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, **HSBC BANK USA**, National Association, in its capacity as administrative agent for the Lenders (the “Administrative Agent”), was granted, pursuant to the Security Agreement dated as of December 23, 2004 among **LIONBRIDGE TECHNOLOGIES, INC.** (the “Grantor”), the other obligors party thereto and the Administrative Agent, a continuing security interest in and continuing lien upon all trademarks, and other properties corresponding thereto, and registrations and applications therefor, together with all goodwill of the business connected with the use thereof and symbolized thereby therein in each case owned by or accruing to the Grantor, including without limitation the registrations and applications listed in Schedule A hereto (the foregoing collectively being referred to hereinafter as the “Trademarks”).

WHEREAS, a Trademark Security Agreement dated December 23, 2004 was recorded with the Assignment Recordation Branch of the U.S. Patent and Trademark Office on January 3, 2005 at Reel/Frame 3000/0381

WHEREAS, a Notice of Grant of Security of Security Interest in Trademarks dated December 21, 2006 was recorded with the Assignment Recordation Branch of the U.S. Patent and Trademark Office on January 29, 2007 at Reel/Frame 3470/0126 and a Corrective Assignment was recorded on February 12, 2007 at Reel/Frame 3482/0147

WHEREAS, a Security Agreement dated December 21, 2006 was recorded with the Assignment Recordation Branch of the U.S. Patent and Trademark Office on October 4, 2010 at Reel/Frame 4289/0872 and a Corrective Assignment was recorded on October 6, 2010 at Reel/Frame 4291/0141

WHEREAS, a Notice of Grant of Security Interest in Trademarks dated December 18, 2014 was recorded with the Assignment Recordation Branch of the U.S. Patent and Trademark Office on January 5, 2015 at Reel/Frame 5434/0034;

WHEREAS, in connection with the Grantors repayment in full and complete satisfaction of all obligations secured by the Trademarks and termination of its credit facility secured by the security interest, the Administrative Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Administrative Agent hereby releases and terminates its security interest in and lien on the Trademarks, including those listed on Schedule A hereto, , and irrevocably reassigns, retransfers and reconveys to Grantor any right, title and interest of the Administrative Agent in or to the Trademarks.
