TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "*Agreement*"), is made and entered into by and between POINT GREY RESEARCH, INC., a Canadian corporation ("*Seller*"), and FLIR INTEGRATED IMAGING SOLUTIONS, INC., a Canadian corporation ("*Buyer*"), effective as of 2.12.17.

WHEREAS, Assignor is the owner of the Trademark (defined in Schedule A herein);

WHEREAS, Assignee is the successor to the aforesaid business of Assignor to which the Trademark pertains; said business being ongoing and existing.

NOW THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:


AGREEMENT

1. **Assignment.** Seller hereby sells, assigns, transfers, conveys and delivers to Buyer, its successors and assigns, all of Seller's right, title and interest in and to the Trademark, including all claims and causes of actions for past infringement of such Trademark and rights to insurance proceeds and under indemnities, guarantees and the like. Buyer shall have the exclusive right to apply for or register such Trademark as it wishes worldwide. The foregoing assignment includes all goodwill of the business associated with or symbolized by such Trademark.

2. **Miscellaneous.** This Agreement will be governed by the governing law provision of the Purchase Agreement. In the event of a conflict between the provisions herein and the terms and conditions of the Purchase Agreement, the terms and conditions of the Purchase Agreement will govern. Notwithstanding any other provision of this Agreement to the contrary, nothing contained in this Agreement will in any way supersede, merge with, modify, replace, amend, change, rescind, waive, exceed, expand, enlarge or in any way affect the provisions set forth in the Purchase Agreement nor will this Agreement reduce, expand or enlarge any remedies under the Purchase Agreement. This Agreement may not be supplemented, altered or modified in any manner except by a writing signed by the parties hereto. This Agreement may be executed in any number of counterparts by the parties hereto in separate counterparts, each of which when so executed and delivered will be deemed an original and all of which counterparts taken together constitute one and the same instrument.
