RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of March 3, 2017, by SJC DLF II-H, LLC, a Delaware limited liability company (“SJC”), acting in its capacity as the agent for the lenders (the “Agent”) and party to (a) that certain Loan and Security Agreement dated as of December 24, 2014 (the “Loan Agreement”), by and among Focus Products Group International, LLC, an Illinois limited liability company, Sure Fit Inc., a Delaware corporation, and Sure Fit Outdoor LLC, a Delaware limited liability company, as borrowers (collectively, the “Borrowers”), and CLP FPG, Inc., a Delaware corporation, as guarantor (the “Guarantor”) and collectively with the Borrowers, the “Obligors”), the lenders from time to time party thereto and the Agent, as term loan lender; and (b) that certain Trademark Security Agreement dated as of December 24, 2014, among the Obligors, as grantors, and the Agent, as lender (the “Trademark Security Agreement”). Terms used but not defined in this Release shall have the meanings given thereto in the Loan Agreement and/or the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement, recorded with the United States Patent and Trademark Office on January 26, 2015 at Reel 5446, Frame 638, the Agent was granted a security interest in and to the Trademark Collateral, including the Trademarks listed on Schedule A (the “Trademarks”);

WHEREAS, the Obligors have requested that the Agent terminate and release its security interests in and to the Trademarks, and that the Lender execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office (“USPTO”); and

WHEREAS, the Agent has agreed to such termination and release.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent hereby releases and terminates all security interests and other interests it may have in the Trademarks. Grantor is authorized to file this Release with the USPTO and any other governmental authority.


The delivery of an executed counterpart of a signature page to this Release shall be effective as delivery of a manually executed counterpart of this Release. The validity, construction and effect of this Release shall be governed by the internal laws of the State of New York (without giving effect to its principles of conflicts of law) and shall relate solely to the Trademark Security Agreement.
