NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Notice of Release of Security Interest in Trademarks is given this [3] day of March, 2017 by PNC Bank, National Association, a United States banking association, solely in its capacity as (in such capacity, the "Secured Party") to M Space Holdings, LLC, a Delaware limited liability company (the "Grantor").

WITNESSETH:

WHEREAS, Grantor granted to Secured Party a security interest in certain trademarks identified on Schedule A (the "Trademark Collateral"), pursuant to a certain Trademark Assignment of Security dated December 12, 2012 and recorded with the United States Patent and Trademark Office on February 6, 2013 in Reel/Frame 4956/0859;

WHEREAS, Secured Party wishes to provide a document suitable for recording in the United States Patent and Trademark office for purposes of recording the release, relinquishment and discharge of its security interest in the Trademark Collateral pursuant to the Sale Order;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Secured Party hereby relinquishes, releases and discharges its security interest in the Trademark Collateral.
