## **INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT**

The Grantor hereby agrees that the attached Supplement to Schedule I to the IP Security Agreement shall constitute part of and an addition to Schedule I to the IP Security Agreement.
