## TRADEMARK ASSIGNMENT

This trademark assignment ("Assignment") is effective as of March 3, 2017 ("Effective Date"), by and between DOMINION ENTERPRISES ("Assignor"), a Virginia general partnership composed of DOMINION ENTERPRISES GROUP, LLC, a Nevada limited liability company, and LTM COMPANY DOMINION, LLC, a Virginia limited liability company, with an address of 150 Granby Street, Norfolk, Virginia 23510, and DOMINION WEB SOLUTIONS, LLC ("Assignee"), a Florida limited liability company with an address of 150 Granby Street, Norfolk, Virginia 23510.

NOW, THEREFORE, in return for good and valuable consideration exchanged between the parties, the receipt and adequacy of each party acknowledges, the parties do hereby agree as follows:

1. Assignment. Assignor hereby irrevocably assigns to Assignee any and all right, title, and interest in and to the Assigned Property, including without limitation all USPTO and U.S. state application, registration, maintenance, and renewal rights with respect to the Assigned Property; all rights to create new marks based on the Assigned Property; all the goodwill of that business that deals in any or all of the goods and/or services with which the Assigned Property has been used or is used, in association therewith; any and all actions and rights of action for infringement, violation, or misappropriation, including without limitation the right to sue and collect damages for past infringement, of the foregoing right, title, and interest in and to the Assigned Property and/or otherwise with respect to the Assigned Property, whether arising before, on, or after the Effective Date; and any and all other rights arising from or associated with the Assigned Property.


