The Assignor further agrees to execute and have executed all documents, instruments and papers and to perform all acts, without any further consideration but at the cost and expense of the Assignee, as deemed reasonably necessary by the Assignee to perfect in the Assignee the foregoing rights, title and interests, including the execution of any related domestic or foreign application documents.

FURTHER, this agreement (or signature page hereto) signed and transmitted by facsimile machine or electronic mail is to be treated as an original document. The signature of any party hereto is to be considered an original signature, and the document transmitted is to be considered to have the same binding effect as an original on an original document.


