BEECHCRAFT CORPORATION, a corporation organized and existing under the laws of the State of Kansas, and TEXTRON AVIATION INC., a corporation organized and existing under the laws of the State of Kansas, do hereby certify as follows:

FIRST: That BEECHCRAFT CORPORATION, a corporation organized and existing under the laws of the State of Kansas and TEXTRON AVIATION INC., a corporation organized and existing under the laws of the State of Kansas (hereinafter sometimes referred to as the "Constituent Companies") have approved and entered into a Plan and Agreement of Merger (the "Agreement") dated as of December 7, 2016, but effective as of January 1, 2017 at 12:00 a.m. CST, which sets forth the terms and conditions of a merger by and between the Constituent Companies (the "Merger"), which has been approved, adopted, certified, executed, and acknowledged by each of the Constituent Companies in accordance with K.S.A. 17-6701 and amendments thereto.

SECOND: That the name of the surviving corporation of said Merger is TEXTRON AVIATION INC., a corporation organized and existing under the laws of the State of Kansas (the "Surviving Corporation"), and its articles of incorporation and bylaws in effect on the Effective Date, as hereinafter defined, shall be and remain the articles of incorporation and bylaws of the Surviving Corporation.

THIRD: That the executed Agreement is on file at the principal place of business of the Surviving Corporation, which is located at One Cessna Blvd., Wichita, Kansas 67215.

FOURTH: That upon the request of any stockholder of the Constituent Companies, a copy of said Agreement will be provided without cost to such stockholder by the Surviving Corporation.




