**TERMINATION AND RELEASE OF
COLLATERAL ASSIGNMENT OF TRADEMARKS**

This Termination and Release of Collateral Assignment of Trademarks ("Release Agreement"), is effective *nunc pro tunc* as of August 9, 2004 and is made by SunTrust Banks, Inc. ("Lender") in favor of Hoover FRT Acquisition Co. ("Grantor").

WHEREAS, Grantor and Lender entered into a Collateral Assignment of Trademarks dated April 2, 2002 ("Collateral Agreement"), whereby Grantor granted Lender, for its own benefit and the benefit of the Lender, a security interest in the Trademarks listed on Schedule A attached hereto (as such term is defined in the Collateral Agreement); and

WHEREAS, the Collateral Agreement was recorded with the U.S. Patent and Trademark Office on April 10, 2002 at Reel 2445 Frame 0443;

WHEREAS, the obligations secured by said security interest have been paid in full or otherwise satisfied; and

WHEREAS, Lender has agreed to terminate and release its security interest and all of its right, title and interest in each of the Trademarks, as herein provided.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby agrees as follows:

1. Release and Assignment. Lender hereby discharges, terminates and releases its security interest in all of the Trademarks, and Lender hereby assigns and transfers to Grantor, without recourse, all of Lender's right, title and interest in and to each of the Trademarks and the related registrations and goodwill, effective as of the date set forth above.

2. Further Assurances. Lender hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release Agreement at Grantor's sole cost and expense.
