## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of January 31, 2017 (the "Effective Date"), is made by Bank of America, N.A., in its capacity as Agent (the "Agent"), in favor of the grantor party identified on the signature page hereto (the "Grantor").

WHEREAS, (i) Eagle OPG, Inc., as predecessor in interest to the Grantor, executed and delivered to Mercantile Bank, N.A. (k/n/a Firststar Bank, N.A.), as agent (the "Prior Agent"), a Patent, Trademark and License Security Agreement, dated as of April 5, 1999 (the "Eagle IP Agreement") and (ii) Adams Business Forms, Inc., as predecessor in interest to the Grantor, executed and delivered to the Prior Agent a Trademark Security Agreement, dated as of November 19, 1999 (the "Adams Trademark Agreement" and, together with the Eagle IP Agreement, the "IP Security Agreements"), in each case, for recordal with the United States Patent and Trademark Office;

WHEREAS, (i) the Eagle IP Agreement was recorded with the United States Patent and Trademark Office on April 9, 1999 at Reel/Frame 1838/0089 and (ii) the Adams Trademark Agreement was recorded with the United States Patent and Trademark office on December 8, 1999 at Reel/Frame 2003/0238;

WHEREAS, the Prior Agent and Agent executed and delivered an Assignment of Security Interest in Patents, Trademarks and Licenses, dated as of November 29, 2000, which was recorded with the United States Patent and Trademark Office on January 8, 2001 at Reel/Frame 2213/0503, pursuant to which the Prior Agent assigned its entire right, title and interest under the IP Security Agreements to the Agent;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:


1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the IP Security Agreements, as applicable.
2. Release. The Agent, without representation or warranty of any kind, hereby releases, discharges, terminates and cancels all of its security interest in and to the trademark registrations and applications set forth Schedule A attached hereto (the "Trademark Collateral"), arising under the IP Security Agreements. If and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral under the IP Security Agreements, the Agent, without representation or warranty of any kind, hereby re-transfers, re-conveys and re-assigns such right, title or interest to the Grantor.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the IP Security Agreements.
4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

5. Governing Law. This Release shall be governed exclusively under the laws of New York, without regard to conflicts of law or choice of law principles.
