RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of March 9, 2017, by **PACIFIC WESTERN BANK** (as successor in interest by merger to Square 1 Bank) ("Lender") in favor of **SHARECARE, INC.**, a Delaware corporation ("Company") with its principal place of business located at 255 E. Recitals

WHEREAS Company granted to Lender a security interest in its Intellectual Property Collateral (as such term is defined in the below-defined Security Agreement), including without limitation the trademarks described on Exhibit A attached hereto under an Intellectual Property Security Agreement dated as of October 21, 2013, a Supplement to Intellectual Property Security Agreement dated as of February 19, 2015, and a Supplement to Intellectual Property Security Agreement dated as of June 1, 2016 (collectively, the "Security Agreement"), and recorded with the US Patent and Trademark Office as set forth on Exhibit A.


WHEREAS as Company has no outstanding obligations to Lender under the terms of the Security Agreement, Lender agrees to release its security interest in the Intellectual Property Collateral.
