## RELEASE OF SECURITY INTEREST IN TRADEMARKS

March 10, 2017

**WHEREAS**, C & K Market, Inc., an Oregon corporation (the “Borrower”), and Crystal Financial LLC, as agent (in such capacity, the “Agent”) for its own benefit and the benefit of the other Secured Parties, entered into that certain Trademark Security Agreement, dated as of August 11, 2014 (as amended or otherwise modified from time to time, the “Trademark Security Agreement”); capitalized terms used herein without definition shall have the meanings assigned to such terms in the Trademark Security Agreement);

**WHEREAS**, pursuant to the Trademark Security Agreement and the other Loan Documents (as defined in the Credit Agreement), the Borrower granted to the Agent a security interest in all of the Borrower’s Trademark Collateral, including those trademarks shown on Exhibit A hereto;

**WHEREAS**, the Agent filed the Trademark Security Agreement with the United States Patent and Trademark Office (the “PTO”) on August 12, 2014 at Reel 005342, Frame 0136;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby terminates and releases its security interest in all of the Trademark Collateral, including, without limitation, those Trademarks identified on Exhibit A attached hereto, effective as of the date first set forth above.

This release may be executed in any number of counterparts, but all of such counterparts shall together constitute but one and the same agreement. Delivery of an executed signature page of this release by electronic transmission shall be as effective as delivery of a manually executed counterpart hereof. The Agent acknowledges that this release may be filed with the PTO to evidence the termination and release granted herein.
