## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release"), dated as of March 3, 2017, is executed by WELLS FARGO BANK, NATIONAL ASSOCIATION, in its capacity as Lender under that certain Credit Agreement (in such capacity, "Lender"), dated as of November 5, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), in favor of CRITERION SUPPLY, INC. (the "Grantor"). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement (as defined below).

### RECITALS

A. WHEREAS, the Grantor has, pursuant to that certain Trademark Security Agreement, dated as of November 5, 2014 and filed with the United States Patent and Trademark Office on November 7, 2014, at Reel 5396, Frame 0384 (the "Trademark Security Agreement"), granted to Lender a security interest in and to all of the Grantor's right, title and interest in and to the Trademarks, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the "Released Collateral"); and

B. WHEREAS, Lender wishes to terminate and release, without representation or warranty, its security interest in and to the Released Collateral as provided in this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Lender hereby terminates and releases, without representation or warranty, its security interest in and to, and hereby reassigns and reconveys to Grantor all of Lender's interest in, the Released Collateral, and terminates the Trademark Security Agreement. Lender acknowledges that this Release may be filed along with any other necessary documentation with the United States Patent and Trademark Office (the "USPTO") or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. Lender authorizes the Grantor to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary to effect the release of Lender's security interest in the Released Collateral.
