TRADEMARK SECURITY AGREEMENT

THIS TRADEMARK SECURITY AGREEMENT (this "Agreement") is entered into as of February 13, 2017 by and among CBY HOLDINGS, LLC ("Grantor"), a Delaware limited liability company, and MERCHANT FACTORS CORP. (the "Secured Party").

RECITALS

WHEREAS, Secured Party entered into an agreement pursuant to which it loaned \$2.5 million (the "Loan") to ET Enterprises Distributors LLC ("ET");

WHEREAS, in order to induce the Secured Party to extend the Loan to ET in the amount of \$2.5 million, Grantor agreed to provide Secured Party with a guarantee of ET's obligations under the Loan arrangement, up to the principal amount of \$2.5 million, without interest, costs, fees or other expenses, and subject to the terms, conditions and limitations set forth in the Guaranty dated as of February 13, 2017 (the "Guaranty"), including the provision that the Secured Party would not seek to enforce the Guaranty unless and until it pursued all of its remedies against ET, ET's collateral, and any other guaranty provided to the Secured Party;

WHEREAS, in order to secure the repayment of the amounts due under the Guaranty (the "Guaranteed Amount"), Grantor has agreed to grant the Secured Party a security interest in the Pledged Trademark Collateral (defined below);

NOW, THEREFORE, in consideration of the mutual promises contained herein and other good and sufficient consideration, the adequacy and receipt of which is hereby acknowledged, the Grantor hereby agrees with the Secured Party as follows:

SECTION 1. Definitions.

(a) Defined Terms in the Guaranty. Unless otherwise defined herein, terms used herein have the meanings given to them in the Guaranty.

(b) Definitions in this Agreement. The following terms, as used in this Agreement, have the following meanings:

"Goodwill" shall mean, collectively, the goodwill connected with such Grantor's business including all goodwill connected with (i) the use of and symbolized by any Trademark or Intellectual Property with respect to any Trademark in which Grantor has any interest, (ii) all know-how, trade secrets, customer and supplier lists, proprietary information, inventions, methods, procedures, formulae, descriptions, compositions, technical data, drawings, specifications, name plates, catalogs, confidential information and the right to limit the use or disclosure thereof by any Person, pricing and cost information, business and marketing plans and proposals, consulting agreements, engineering contracts and such other assets which relate to such goodwill and (iii) all product lines of such Grantor's business.

"Proceeds" shall have the meaning set forth in Article 9 of the UCC.

"Trademarks" shall mean, collectively, all trademarks (including service marks), slogans, logos, certification marks, trade dress, uniform resource locations (URL's), domain names, corporate

names and trade names, whether registered or unregistered, owned by or assigned to such Grantor and all registrations and applications for the foregoing (whether statutory or common law and whether established or registered in the United States or any other country or any political subdivision thereof), together with any and all (i) rights and privileges arising under applicable law with respect to such Grantor's use of any trademarks, (ii) reissues, continuations, extensions and renewals thereof and amendments thereto, (iii) income, fees, royalties, damages and payments now and hereafter due and/or payable thereunder and with respect thereto, including damages, claims and payments for past, present or future infringements thereof, (iv) rights corresponding thereto throughout the world and (v) rights to sue for past, present and future infringements thereof.

SECTION 2. Grant of Security Interest in Trademark Collateral. To secure the Guaranteed Amount due to the Secured Party under the terms of the Guaranty, Grantor hereby pledges and grants to Secured Party a lien on and security interest in and to all of Grantor's right, title and interest in, to and under all the following property, in each case wherever located and whether now owned or existing or hereafter owned, arising or acquired from time to time (collectively, the "Pledged Trademark Collateral"):

- (a) all now existing or hereafter acquired Trademarks owned by the Grantor in the United States, including, without limitation, those listed on Schedule A attached hereto;
- (b) all Goodwill associated with such Trademarks; and
- (c) all Proceeds of any and all of the foregoing.

SECTION 3. Termination. Upon the indefeasible payment in full of the Guaranteed Amount in cash, or the payment in full of the Loan in cash, or the provision of a letter of indemnity in a form and substance acceptable to Secured Party, the Secured Party shall execute, acknowledge, and deliver to the Grantor an instrument in writing in recordable form releasing all of its rights under this Agreement, including, without limitation, the collateral pledge, grant, assignment, lien and security interest in the Pledged Trademark Collateral under this Agreement.

SECTION 4. Secured Party's Covenants. The Secured Party acknowledges and agrees that this Agreement is subject to the conditions set forth in paragraph 1(a) of the Guaranty and that it will not attempt to foreclose on, or otherwise enforce, its lien and security interest set forth in Section 2 above unless and until the conditions to the enforceability of the Guaranty delineated in paragraph 1(a) of the Guaranty have been satisfied and unless and until the Grantor defaults under the terms of the Guaranty. The Secured Party further acknowledges and agrees that, if ET is not in default of its obligations under the Loan and the Grantor is not in default of its obligations under the Guaranty, the Secured Party will not claim any right that would prevent the Grantor from selling, assigning or transferring any of the Pledged Trademark Collateral, subject to the terms of this Agreement, or from pursuing any rights that the Grantor has against ET under the terms of any agreement as to which ET is a party including, without limitation, the Grantor's operating agreement or the agreement pursuant to which ET acquired an interest in the Grantor.

SECTION 5. Counterparts. This Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Agreement by signing and delivering one or more counterparts.

SECTION 6. GOVERNING LAW. THIS AGREEMENT SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.


