**RELEASE OF SECURITY INTEREST IN  
TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (the "Release") is dated as of February 8, 2017 by WELLS FARGO BANK, NATIONAL ASSOCIATION, as agent for certain lenders (the "Agent"), in favor of SYCUAN BAND OF THE KUMEYAAAY NATION, a federally recognized Indian tribe (the "Band"), on its own behalf and doing business as SYCUAN CASINO, an enterprise organized by the Band under its internal ordinances for conducting gaming activities (collectively, the "Grantor").

Grantor executed an ASSIGNMENT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS AND PATENTS dated as of May 12, 2011 in favor of Agent, whose address is 3800 Howard Hughes Parkway, 4<sup>th</sup> Floor, Las Vegas, Nevada 89109 (as amended from time to time, the "Security Agreement").

Pursuant to the Security Agreement the Grantor granted to Agent, for the benefit of the lenders, a security interest in and to all of Grantor's right, title and interest in Grantor's trademark and service mark rights, trademark and service mark registrations, and applications therefor, including those specific trademark registrations and applications listed on Exhibit A attached hereto (the "Released Marks"), and the goodwill associated therewith. The Security Agreement was recorded on May 13, 2011 at Trademark Reel/Frame 004542/0581 in the United States Patent and Trademark Office.

Agent wishes to release and retransfer to Grantor, without representation or warranty, all of Agent's right, title and interest in and to the Released Marks, all products thereof, all goodwill associated therewith, all causes of action for infringement related thereto, and all proceeds of the foregoing (collectively, the "Trademark Collateral").

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Released Marks and Trademark Collateral, and retransfers to Grantor, without representation or warranty of any kind, express or implied, free and clear of any claims by Agent, all of Agent's right, title and interest in and to the Released Marks and the Trademark Collateral.
