PUERTO RICO TRADEMARK ASSIGNMENT

ASSIGNMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is dated as of January 20, 2017 (the "Effective Date"), between St. Jude Medical Puerto Rico, LLC, a Puerto Rico limited liability company ("Assignor"), and Terumo Puerto Rico L.L.C., a Puerto Rico limited liability company ("Assignee"). Assignor and Assignee may be referred to herein collectively as the "Parties" and individually as a "Party".

WHEREAS, Assignor desires to transfer and assign to Assignee, and Assignee wishes to acquire and assume from Assignor, the trademarks and trademark applications set forth on Schedule A (the "Trademarks"), effective as of the Effective Date, upon the terms and subject to the conditions set forth in this Assignment.

NOW, THEREFORE, in consideration of the premises, mutual covenants, agreements and provisions herein contained, and intending to be legally bound, the Parties hereto agree as follows:

1. Assignment and Assumption of the Trademarks. For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by Assignor, Assignor hereby assigns, transfers and conveys unto Assignee, and Assignee hereby accepts, Assignor's whole and entire right, title and interest in and to the Trademarks together with the goodwill attaching thereto and any common law rights therein.

2. Enjoyment. The trademarks and trademarks applications subject to Section 1 shall be held and enjoyed by Assignee, for Assignee's use and benefit, and for Assignee's legal representatives and assigns, as fully and entirely as the same would have been held by Assignor had this assignment and transfer not been made.

3. Further Documents. Each of the parties to this Assignment shall, at any time or from time to time, and shall cause their respective affiliates to, execute and deliver such other assurances, documents and instruments, provide such materials and information and take such other actions as may reasonably be necessary, proper or advisable, to the extent permitted by law, to fulfill its obligations under this Assignment.


