PIRELLI hereby confirms that, effective as of 31st day of December 2016, Pirelli has assigned to Zafco, pursuant to a certain prior "Trademark License, Trademark Applications and Registration Assignment and Mould Lease and Sale agreement" dated April 23, 2012 (the "**Separate Agreement**"), against the payment -by Zafco to Pirelli- and in exchange of the receipt -by Pirelli- of the consideration set forth in the Separate Agreement, all of Pirelli's right, title, interest in and to the Trade Mark Applications and Registrations as set forth herein.

For the purpose of this Assignment Confirmation:
